INSTRUCTIONS TO DEFENDANT**

1. You have been ordered to enroll in a Drug Program pursuant to PC 1000. You **must** select one of the approved providers on the “Certified Drug Programs – PC 1000 Approved 32 Hour Drug Education Programs” list.
2. **Immediately contact** the program of your choice for enrollment.
3. It is your responsibility to provide proof of *enrollment* and *completion* on dates ordered by the Court.
4. It is your responsibility to **appear in court** on the date ordered by the Court for the Sentencing/Dismissal Hearing.
