#### **ITEM #1 PUBLIC HEARING – TENTATIVE PARCEL MAP 2016-170**

**LOCATION:** The project site is located in the North Tustin area 10072 Rangeview Drive, Santa Ana, unincorporated North Tustin area, Third Supervisorial District (APN 503-194-38, -39)

**APPLICANT: RANGEVIEW PARTNERS LLC**

Staff requests the Subdivision Committee review and approval of TPM 2016-170, which would subdivide 10072 Rangeview Drive into two parcels, with a minimum net building site area of 20,000 square feet per parcel.

#### **RECOMMENDED ACTION:**

- a) Receive staff report and public comment, as appropriate;
- b) Find that the proposed project (TPM 2016-170) is Categorically Exempt (Class 15- Minor Land Divisions) from the provisions of CEQA pursuant to Section 15315 of the CEQA Guidelines; and:
- c) Approve Tentative Parcel Map 2016-170, subject to the attached Findings and Conditions of Approval (Attachment 1).
