Hall of Administration Parking Lot Closure

Due to the demolition of the building west of the Hall of Administration, the Hall of Administration parking lot will be closed on January 11, 2017. Beginning January 12, 2017 through the end of March, a majority of the lot will remain closed with a total of 64 parking spaces available along the south side of the lot.

There will be eight ADA-access parking spaces located within the parking lot during the demolition. An open pathway to the existing access ramp (located on the northeast corner of the lot) will be made available.

Please note: If you have an oversized vehicle that does not fit in the Health Care Agency parking structure, you may park in one of two locations and still obtain parking validation from our office.

These parking lots are:

- **Parking Lot 2:** Adjacent to the Superior Court-Central Justice Center, east of Flower Street between Civic Center Drive and Santa Ana Boulevard.
- **Parking Lot 6:** Adjacent to the State Building and Appellate Court, west of Ross Street on the north side of Santa Ana Boulevard.

Once the building demolition has been completed, the parking lot will be re-opened until the construction of the new building begins.

Additional parking information will be made available when received.

PARKING LOT CLOSURE

On Jan. 11, 2017, the Hall of Administration parking lot will be closed due to Building 16 demolition activities. Beginning Jan. 12, the north portion of the lot will be closed, with intermittent full lot closures as needed.
