

**ORANGE COUNTY HOUSING AUTHORITY  
MENTAL HEALTH SERVICE ACT (MHSA)/PROJECT BASED VOUCHER APPLICATION  
DORIA APARTMENT HOMES Phase II**

The Orange County Housing Authority (OCHA) is accepting applications for Project Based Vouchers (PBVs) for an affordable housing project consisting of **eight (1) bedroom** and **two (2) bedroom** apartments at Doria Apartment Homes Phase II. This PBV can only be used to receive housing assistance at Doria Apartment Homes Phase II. In accordance with Chapter 17, Part VI, C of the OCHA Administrative Plan, eligible applicants on OCHA's Housing Choice Voucher (HCV) waiting list who indicated an interest in moving to a PBV property have been notified of this opportunity. This opportunity is now being extended to other eligible persons who meet the requirements listed below and may qualify for a PBV apartment. Interested persons **must meet both listed eligible criteria** and must follow the instructions below. The application period for this project will remain open until further notice.

**Doria Apartment Homes Phase II** is an affordable housing complex for disabled families who have special needs and is located at 1000 Crested Bird, Irvine, CA 92620

Total Household Income may not exceed 30% of Orange County Area Median Income as indicated below:

To be eligible for the MHSA units, property owners will accept applicants who meet the following eligible criteria:

**1. Mental Health Services Act (MHSA) Eligibility (must check at least 1 box)**

- Adult or older adult with a severe and persistent mental illness (as defined in Welfare and Institutions Code 5600.3)
- Individual has a co-occurring mental health and substance abuse disorder

**2. Homeless or At Risk of Homelessness status (must check at least 1 box)**

- Living on the streets
- Living in an emergency shelter or in transitional housing
- Living in an institutional setting (e.g. jail, juvenile hall/camp, psychiatric hospital or IMD) and will be Homeless upon release
- Temporarily living in a residential care facility
- Facing eviction & unable to identify a new residence
- Living in an overcrowded setting in which they do not hold a lease
- "Doubling up" or "couch surfing" due to economic hardship
- Living in motels, hotels, trailer parks or camp grounds

**If you meet both eligible criteria 1 & 2 above** and are interested in applying for these MHSA PBV units, please complete this form and **fax** to Orange County Health Care Agency (OCHCA) at **714-667-3968** to obtain an approved MHSA Eligibility Certification. **Please do not contact Orange County Housing Authority** as you must be screened and referred by OC Health Care Agency.
