



NOTICE OF PUBLIC HEARING

BY THE ORANGE COUNTY BOARD OF SUPERVISORS

SUBJECT: County of Orange Landscape Irrigation Code and Associated Guidelines (Zoning Code Amendment ZCA 15-02).

DESCRIPTION: The Board of Supervisors will conduct a public hearing to consider the adoption of an Ordinance revising Sections 7-9-133.1 through 7-9-133.5 of the Codified Ordinances of the County of Orange regarding the “County of Orange Landscape Irrigation Code” and associated “Guidelines for Implementation of the County of Orange Landscape Irrigation Code” (ZCA 15-02) to comply with Governor’s Drought Executive Order and Statewide Model Water Efficient Landscape Ordinance (MWELO).

SUMMARY: AN ORDINANCE OF THE COUNTY OF ORANGE, CALIFORNIA AMENDING SECTIONS 7-9-133.1 THROUGH 7-9-133.5 OF THE CODIFIED ORDINANCES OF THE COUNTY OF ORANGE RELATED TO THE COUNTY OF ORANGE LANDSCAPE IRRIGATION CODE.

LOCATION: Unincorporated areas of the County of Orange.

APPLICANT: County of Orange.

PREVIOUS ACTIONS: On January 27, 2016, the Planning Commission considered the proposed update to the County of Orange Landscape Irrigation Code and associated Guidelines for Implementation of the County of Orange Landscape Irrigation Code (Zoning Code Amendment CA 15-02). After closing the public hearing, the Planning Commission voted to adopt Resolution No. 16-01, which recommends adoption of the Ordinance by the Board.

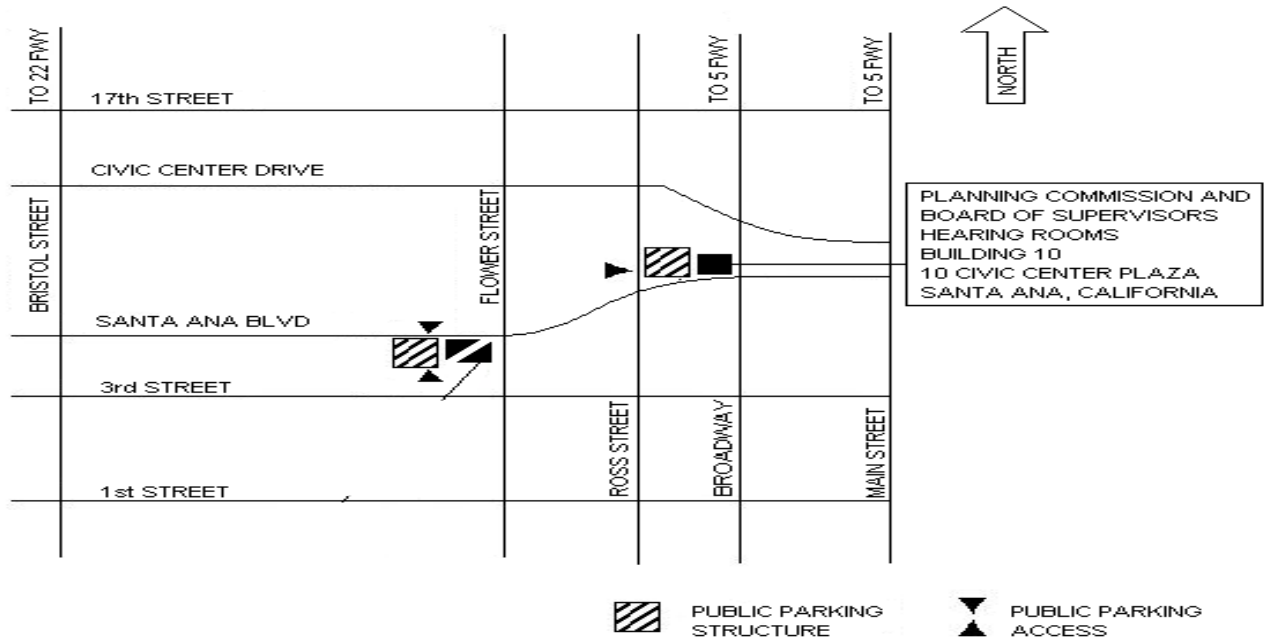
