



NOTICE OF PUBLIC HEARING

SUBJECT: Continuation from the September 27, 2017 Public Hearing on Planning Application PA080053 "Red Rock Gardens" to receive public testimony and to consider a recommendation to the Planning Commission regarding a proposed Use Permit for an approximately 6.7-acre property.

PROPOSAL: A Use Permit to establish a commercial outdoor recreation event facility "Red Rock Gardens" to host events (weddings, anniversaries, parties, and fundraisers) with a maximum of 200 guests and 20 events per calendar year, including a modification to parking standards on an existing residential site.

LOCATION: The project is located at 17521 Santiago Canyon Road, at the intersection Santiago Canyon Road and Bolero Lookout Road, within the Third (3rd) Supervisorial District.

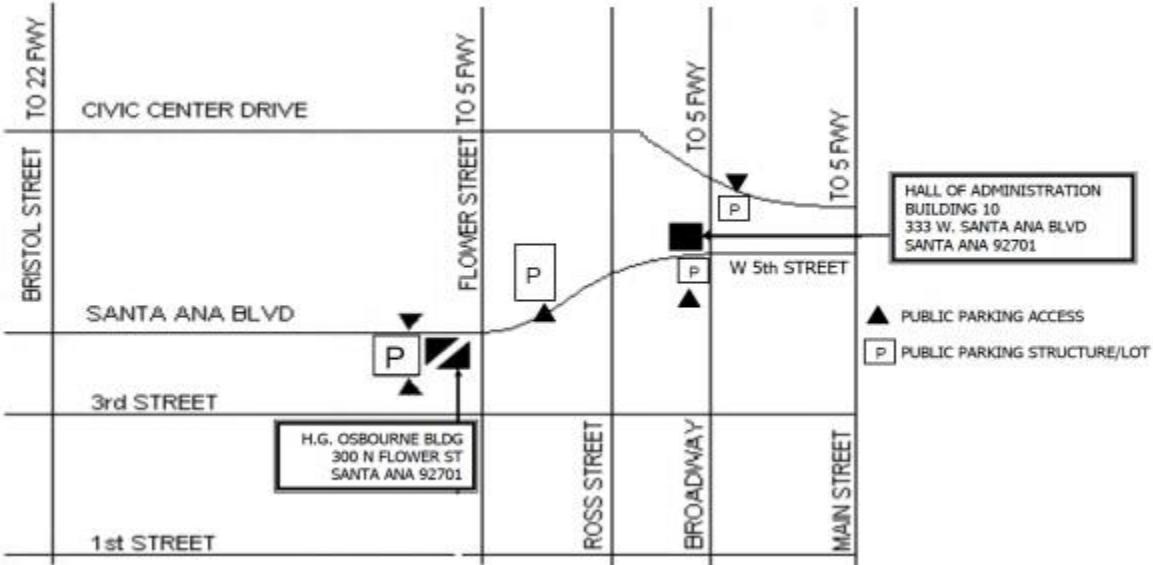
