



NOTICE OF PUBLIC HEARING

BY THE ORANGE COUNTY PLANNING COMMISSION

SUBJECT: Planning Application PA170028 for a Site Development Permit.

PROPOSAL: Site Development Permit for two parcels, Parcel 1 for grading in excess of 500 cubic yard on slopes greater than 30% and construction of a new three-story Single-Family residence with attached three-car garage, a new split-level second residential unit with retaining walls, Parcel 2 for grading in excess of 500 cubic yards on slopes greater than 30% and construction of room additions to an existing Single-Family Residence including attached garages, attached pool house, and rear yard pool, spa and paved patio area.

LOCATION: The Project site is located at 30911 Barnes Trail (Parcel 1) and 31011 Hamilton Trail (Parcel 2), Trabuco Canyon, within the Third (3rd) Supervisorial District.

ZONING: Foothill/Trabuco Specific Plan, Trabuco Canyon Residential (TCR) District

APPLICANT: Tom Brooks, Property Owner

ENVIRONMENTAL DOCUMENTATION: Staff proposes that the proposed project is statutorily exempt under California Code of Regulations Title 14, Section 15182 and Government Code Section 65457(a), which exempt residential development project that are consistent with a specific plan for which an environmental impact report was certified after January 1, 1980. Final Environmental Impact Report ("EIR") No. 531, certified on December 10, 1991 for the Foothill Trabuco Specific Plan is such a specific plan, and this residential development is consistent with it.

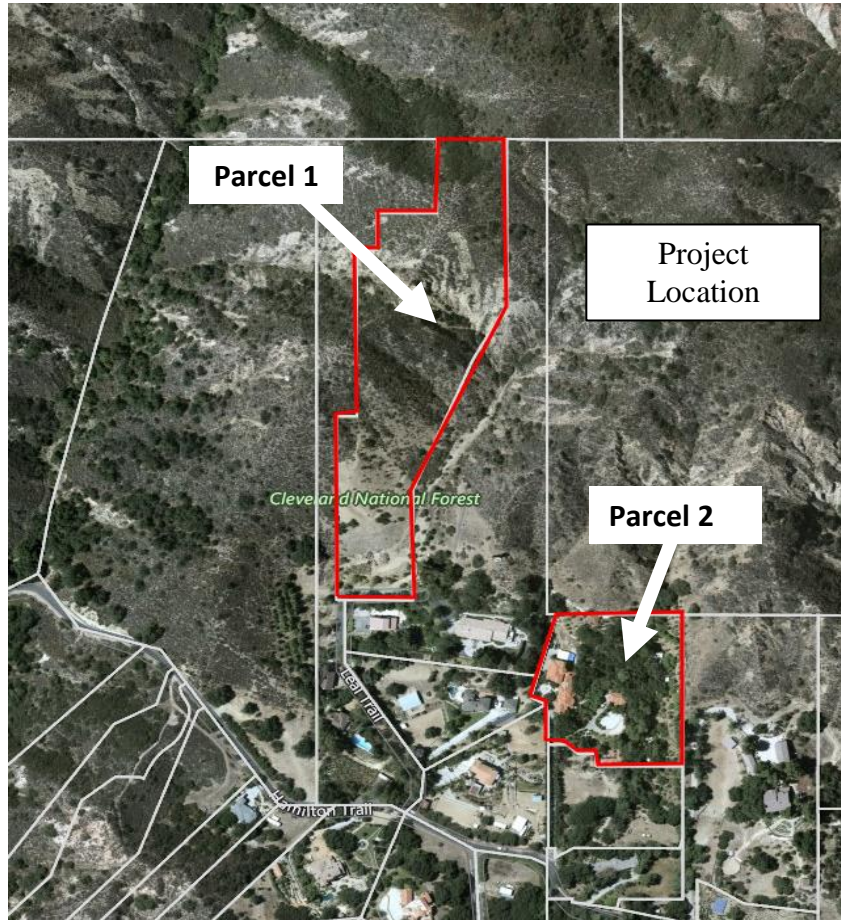
INVITATION TO BE HEARD:

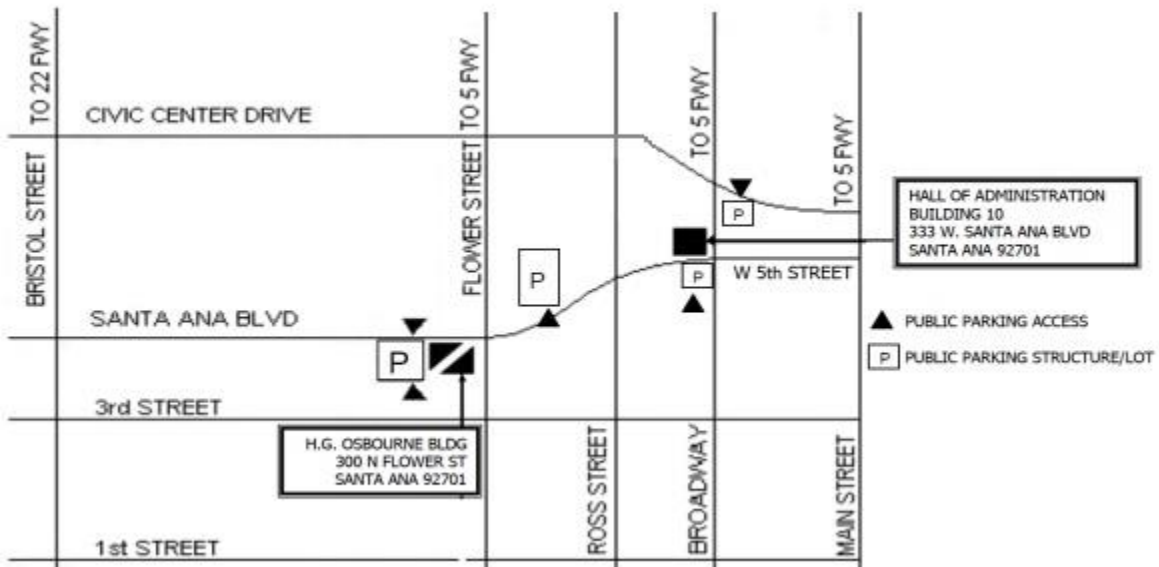
